**Excise (Valuation of Excisable Goods

Citation and commencement

1.—(1) These Regulations may be cited as the Customs (Budget Amendment) Regulations 2010 and shall commence on the 1st January 2010.

(2) In these Regulations, the Customs Regulations 1986 is referred to as “principal Regulations”.

Customs (Prohibited Imports and Exports) (Budget Amendment) Regulations 2010

In exercise of the powers conferred on me by Section 64 of the Customs Act, 1986, I make these regulation—

Citation and commencement

1.—(1) These Regulations may be cited as the Customs (Prohibited Imports and Exports) (Budget Amendment) Regulations 2010 and comes into force on 1st January 2010.

(2) In these Regulations, the Customs (Prohibited Imports and Exports) Regulations, 1986, is referred to as the “principal Regulations”.

Regulation 3 amended
