



**FIJI REVENUE & CUSTOMS AUTHORITY
PUBLIC CIRCULAR NO. 18 OF 2011**

REVISED FEES AND CHARGES

1. Customs Agents, Importers, Exporters, Airline and Shipping Companies and General Public at large are advised that fees and charges stipulated in various regulations have now been revised.
2. The revised fees and charges specified in the table below will be effective from 1st January, 2012.
3. The miscellaneous fees and charges has been increased by 2.5% due to increase in Value Added Tax from 12.5% to 15%. In order to accommodate the increase in fees and charges additional stickers has been printed which the stakeholders are required to utilize while making the payment. However any amount that cannot be covered by the stickers will have to be paid and will be collected on CDFR by the cashier.
